Weber & Co. advises Joint Lead Manager on the issue of EUR 750 million Mortgage Pfandbriefe by Erste Group

The EUR 750,000,000 0.100% Mortgage Pfandbriefe due 2030, ISIN AT0000A2CDT6, were issued on 15 January 2020 under Erste Group Bank AG's Covered Bonds Programme. They have a maturity until 2030 and a denomination of EUR 100,000 each and are listed on the Official Market of the Vienna Stock Exchange. The transaction is the first issue of Mortgage Pfandbriefe in Austria in 2020.

(Italy), Dankse Bank A/S (Denmark), DekaBank Deutsche Girozentrale (Germany), DZ BANK AG Deutsche Zentral-Genossenschaftsbank, Frankfurt am Main (Germany), Erste Group Bank AG (in its capacity as Joint Lead Manager) and Landesbank Baden-Württemberg (Germany) acted as Joint Lead Manager for the issue. Wolf Theiss (lead partner Claus Schneider) advised Erste Group Bank AG as issuer. Already in May 2019 and in September 2019, Weber & Co. had advised the Joint Lead Managers and Wolf Theiss had advised Erste Group as issuer on two issues of Mortgage Pfandbriefe in a transaction size of EUR 500 million each.
